

Highways (DF activities in support of SC)

LHI 2017/18 - grant application submitted 09/11/2016; case presented to assessment panel 08/02/2017 at CCC Highways office, Hereward House, March. Proposal is to complete the work already started under LHI 2016/17, i.e., improve the remainder of the footway to the Common Cottages entrance (a distance of 64m). Estimated total cost £9000; our contribution £1200. I think the transition from old to new makes the case (see picture opposite). The outcome will be known soon after the Highways and Community Infrastructure Committee meeting Tuesday 14th March 2017.




Way Ahead. Meeting 22/02/2017 - SC/DF with Rigney/Nicholson (CCC) - at March Highways Depot to discuss footway maintenance, LHI and third party funding options. SC WILL LEAD AT PC MEETING RE: OUTCOME.

At end of FY 2017/18 Highways may have funding available for maintenance of a short section of the footway outside 176 High Road (note owner will be required to realign boundary fence).

LHI 2018/19 - the intention is to address the problem of the very narrow (0.50m) footway where a culvert passes under the High Road near Goodens Lane. This is an ideal candidate requiring new work to relocate the safety railings to gain extra width without the need for a kerb build-out. This could be combined with CCC funded maintenance work to improve the short section of footway extending west to the Goodens Lane junction, and a short section extending east to join the refurbished section completed by CCC this year.

LHI 2019/20 - consider improvement in response to Mrs Dee Page's letter to NPC dated 12 April 2016. Relocate 40mph speed restriction signs at east end of village from outside 156, High Road, in an easterly direction to coincide with the existing village sign at entry to the village. This would also extend the 40mph limit into Rectory Road to the existing 30mph limit. Also consider signage warning vehicles to be aware of pedestrians in the road where no footway exists (especially from 156, High Road, to the High Road/Rectory Road junction).

Parish Council Report - March 2017

January and February are traditionally two of the quietest months for the Hall and this year was no exception. Apart from the regular programme of club bookings and activities, we hosted one party and a funeral wake.

Our Valentine's Quiz was quite successful, raising £176. This is something we plan to repeat periodically, although there are a number of other organisations running quizzes, so we need to plan around their timetables. We have no specific plans for future fundraising events, although we may attempt a Craft Fair later in the year.

The grant of £500 from the Parish Council has enabled us to bring forward some of our planned improvements to the Hall and we hope to complete some initial works before the end of the current financial year.

There is no further news regarding the future of the Post Office counter service, so for the time being, it will continue. The Post Office has recently launched a new service providing banking facilities for personal and business customers of all major banks, so we hope to have an opportunity to advertise this in the hope of increasing footfall.

It is too early to predict our year-end financial position precisely, but at this stage we anticipate a shortfall of between £500 and £1,000.
